- New SBA loan applications: Immediate halt

## Critical Timeline:

- Passport applications: Apply 90 days before travel
- Other federal applications: Add 4-6 weeks buffer

# Understanding Government Shutdowns

## What Is a Government Shutdown?

A government shutdown—formally called a "lapse in appropriations"—occurs when Congress fails to pass funding legislation or a Continuing Resolution (CR) before the fiscal year ends (typically September 30th).

When funding expires, federal agencies relying on annual appropriations must cease non-essential operations under the Antideficiency Act. This law prohibits agencies from spending money they haven't been authorized to spend.

## What Determines Which Services Continue?

Funding mechanism determines continuity:

### Mandatory Spending (Protected)

- Social Security, Medicare, Medicaid
- Funded by permanent law, not annual appropriations
- Continue automatically during shutdowns

### Discretionary Spending (Vulnerable)

- National Parks, SBA operations, FAFSA processing
- Require annual Congressional approval
- Stop immediately when funding lapses

### Fee-Funded Services (Generally Protected)

- Passport operations, USPS
- Self-funded through user fees
- Can continue but may slow due to support service dependencies

### Excepted Activities (Continue with Delayed Pay)

- TSA, air traffic control, law enforcement
- Essential for public safety
- Employees work without immediate pay

# Services That Continue

---

## Social Security & Supplemental Security Income (SSI)

**Status:** **Payments Continue On Time**

Monthly benefit checks arrive as scheduled regardless of shutdown duration. These programs operate under indefinite appropriations separate from the annual budget process.

---

**Important caveat:** While payments continue, local Social Security Administration field offices may operate with reduced staff, causing delays for:

- New benefit applications
  - Appeals processing
  - Complex eligibility determinations

# Medicare & Medicaid

---

Status: **Full Coverage Continues**

---

All Medicare and Medicaid services remain active:

Doctor visits

Hospital care

Prescription drug coverage

Medical procedures

---

These entitlement programs are funded independently of annual appropriations.

# Department of Veterans Affairs (VA)

Status: **Core Services Continue, Support Services May Stop**

## Services That Continue:

- Disability compensation payments
- Pension payments
- VA medical care and hospitals
- Veterans Crisis Line: 988, Press 1 (24/7)
- Dependency and Indemnity Compensation (DIC)

## Services That May Be Suspended:

- Veteran Readiness & Employment (VR&E/Chapter 31) outreach
- GI Bill Hotline (Education Call Center)
- Transition Assistance Programs (TAP)
- Some cemetery maintenance (interments continue)

**Why the difference?** Core payments and medical care operate on separate funding, while support services rely on annual appropriations.

# Transportation Security & Air Traffic Control

---

Status: **Operations Continue**

---

TSA security screening and air traffic control remain fully operational. You can travel by air without safety concerns.

---

**Critical detail:** TSA officers and air traffic controllers are "excepted employees" who must work without immediate pay. In prolonged shutdowns, this can lead to staffing challenges.

# Law Enforcement & Border Security

---

Status: [Operations Continue](#)

---

Federal law enforcement agencies remain operational:

- Customs and Border Protection (CBP)
  - Federal Bureau of Investigation (FBI)
  - Secret Service
  - Federal Protective Service
- 

All personnel are classified as essential and continue working (without immediate pay).



# Military Operations

---

**Status:** **Operations Continue, Pay May Be Delayed**


---

National defense and military operations continue without interruption. Active duty personnel remain on duty.

**Pay status:** Military paychecks depend on annual appropriations and may be delayed unless Congress passes targeted funding legislation (often done but not legally guaranteed).

# United States Postal Service (USPS)

---

**Status:** **Completely Unaffected**

Mail delivery continues normally. USPS is self-funded through postage sales and operates independently of annual appropriations.

## Services That Stop or Experience Delays

# Passport Services

---

**Status:** **Services Continue But Processing Slows**

**Current reality:** Passport operations are fee-funded and typically continue during shutdowns. However, processing slows significantly due to dependencies on other agencies.

### Why delays occur:


- FBI background checks may be suspended
- DHS verification processes may halt
- Inter-agency clearances slow or stop

**Buffer recommendation:** Apply at least 90 days before international travel.

### Current processing times:

- Routine: 4-6 weeks + 2 weeks mailing
- Expedited: 2-3 weeks + 2 weeks mailing
- Shutdown buffer: Add 2-4 weeks minimum

# National Parks

---

**Status:** [Most Close Entirely](#)

National Park Service contingency plans typically mandate closing the majority of parks to public access during shutdowns.

**Why full closures?** Without appropriated staff (rangers, maintenance, facilities), parks cannot ensure visitor safety or protect natural resources.

**Planning tip:** Check individual park websites before traveling. Some may remain accessible with zero services (no restrooms, no visitor centers, no emergency assistance).

# Internal Revenue Service (IRS)

**Status:** **UPDATED - Most Operations Continue**

**Critical update:** Unlike historical shutdowns where the IRS furloughed most staff, current policy has changed.

**Why IRS now continues:** The Inflation Reduction Act (2022) provided supplemental appropriations through September 30, 2031, allowing the IRS to maintain operations during shutdowns.

## What continues:


- Tax return processing
- Refund processing
- Core taxpayer services

## What may slow:

- Some support services
- Complex case resolution
- In-person assistance

**Tax filing deadlines:** ALWAYS unchanged during shutdowns. You must file on time to avoid penalties.

# Federal Student Aid (FAFSA)

---

**Status:** **Processing Delays Expected**

New FAFSA applications may not be processed during shutdowns. Administrative staff handling verification and aid determinations are often furloughed.

**What continues:** Existing student loan servicing

**What stops:** New application processing, verification, aid package determination

**Buffer recommendation:** Submit FAFSA as early as possible (opens October 1 for following academic year).

# Small Business Administration (SBA)

---

## Status: **New Loan Applications Halt Immediately**

The SBA stops processing new loan applications:

- 7(a) loans
- 504/CDC loans
- Disaster loans
- Even Preferred Lender Program applications (if SBA number not yet assigned)

**What continues:** Existing loan payments and servicing

**Post-shutdown reality:** Expect extended processing times (4-8 weeks additional) as SBA works through accumulated backlog.

# Federal Employee & Contractor Pay

---

**Status: Federal Employee Pay Delayed,  
Contractors Not Protected**

## Federal Employees:

- All employees (furloughed and excepted) experience pay delays
- Back pay is legally guaranteed by Government Employee Fair Treatment Act (2019)
- Payments resume when government reopens

## Government Contractors:

- May face immediate job loss or pay cessation
- NO legal guarantee of back pay
- Permanent income loss possible

This disparity affects millions of private-sector workers performing federal functions.



# Nutrition Assistance Programs

Status: **SNAP Secure Short-Term, WIC Highly Vulnerable**

## SNAP (Supplemental Nutrition Assistance Program):


- Typically continues for first month using contingency funds
- States can maintain benefits through reserve funding
- Extended shutdowns (30+ days) may cause disruption

## WIC (Women, Infants, and Children):

- Discretionary program with limited state reserves
- May face disruption within 1-2 weeks in some states
- Continuation depends entirely on individual state funding reserves

**Critical action:** Check your state's Department of Health or Agriculture website for state-specific contingency plans.

# Preparation Checklist

## Before a Shutdown:

- Apply for passport 90+ days before international travel
- Submit federal applications with 4-6 week buffer
- Download agency contingency plans from .gov websites
- Save important agency phone numbers offline
- Review state contingency plans for nutrition programs

02

---

## During a Shutdown:

- Monitor agency websites for updates
- Expect 2-4 week delays for new applications
- Check state resources for SNAP/WIC status

03

---

## After a Shutdown:

- Allow 4-6 weeks for backlog processing
- Follow up on pending applications
